

When setting up our benefits with Capital Blue Cross there were two issues with the RX set up. One issue was the Over the Counter (OTC) drugs available at a generic copay and the other was the 2X retail copay for a 90 day supply at any retail pharmacy. Both required a manual update to Capital Blue Cross' system which could not be implemented in time for January 1st. Both issues are being worked on and we anticipate them being complete soon. Those that were impacted by the 90 day at retail issue will get a refund for the extra out of pocket they paid once this is updated. Thank you for your patience while these items are updated!

Effective March 1st Assurant Dental is changing over to Sunlife Financial. New Dental cards with the Sunlife logo and group ID will be provided to everyone enrolled next week. Our dental plan will remain the same, the only change is the name. A shout out to HR for all their efforts in making this transition relatively seamless!



Mercy House **Substance Abuse Recovery**

This week we submitted our application for a certificate of appropriateness with Gettysburg Historical Architectural Review Board (HARB). While this is only the first step in the permit process, it is important to the overall functionality of the recovery center to have operable windows and the addition of an elevator to the building. Both of these items will impact the exterior of the building, thus the need for a historic review. This month we will also host a neighborhood meeting and have invited the immediate neighbors to attend and learn more about the operation and benefits of a recovery center. County and RASE Project staff will be on hand to present information and answer any questions. We are looking forward to adding more recovery services to combat the opioid and substance abuse epidemic facing our residents.

Senior Management Meetings Resume

Computer Aided 911 Dispatch to Launch Soon

The Department of Emergency Services, in conjunction with the IT Department, has initiated the process of building a new Computer-Aided Dispatch (CAD) network at the County's 911 Communications Center. CAD is a computer based system that assists 911 Dispatchers in prioritizing and dispatching first responders to requests for assistance. The system will interface with the 911 telephone system and the County's 800 Mhz Digital Trunked Radio System. CAD also provides law enforcement with in-car information on their laptop computers.


This new network will have more redundancy and be more resilient than the current system; both are important characteristics in the Public Safety Communications arena. Additionally, the new network will allow for growth and adaptation, as new technology develops. The current CAD network is seven years old; outliving the normal life expectancy by two years. It is anticipated that the new network will be on-line in approximately 90 days.
