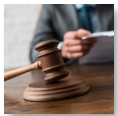

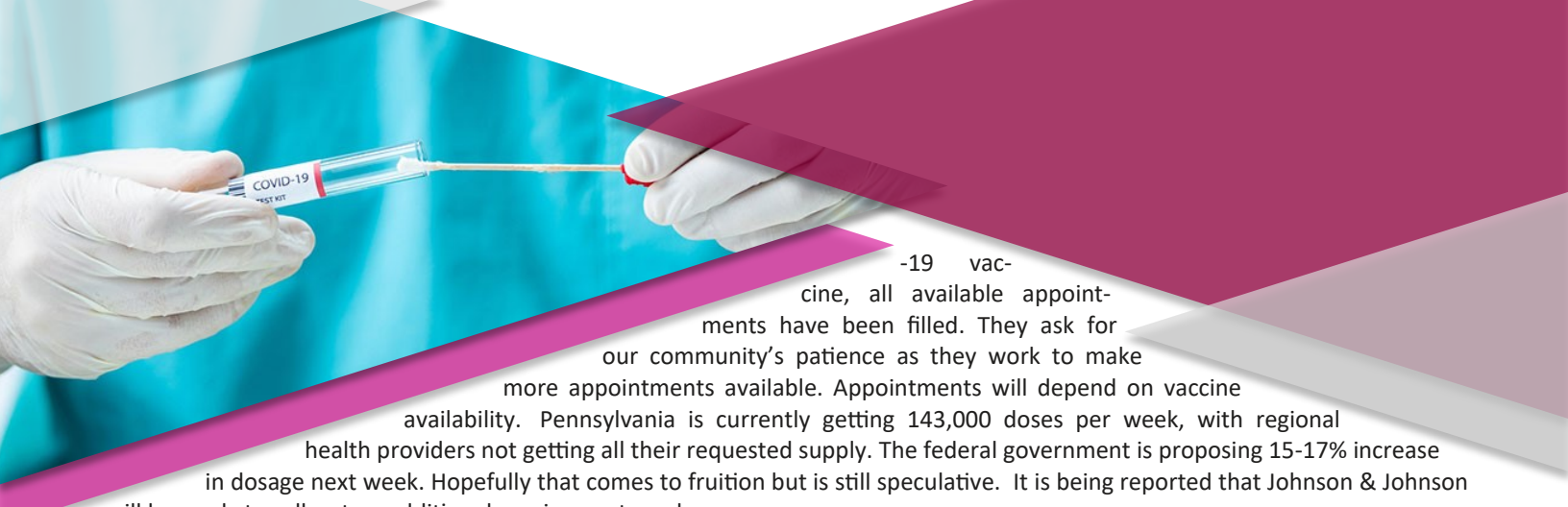

COVID *Vaccination Update*

One of the most frequent questions that the County has been receiving of late has been, “who is overseeing and managing the COVID-19 vaccine rollout and where can I get it?” The mass vaccination plan is managed by the Pennsylvania Department of Health (PA DOH). Adams County has offered to support the PA DOH in any way possible to help with the process. We are awaiting the PA DOH to provide information regarding how the County can continue to assist. The County does not control when the vaccine is delivered to our county, when we transition to the next phase, or what groups are included in the various phases. At this time the County has posted available information from the PA DOH on the County website <http://www.adamscounty.us/Pages/Covid19VaccineandInformation.aspx> As of yesterday we have updated the county website with an easy to understand and maneuver Question & Answer Tab. Currently, we are in Phase 1A of the rollout. WellSpan is the current local provider of the vaccine. As of 1/28/21, WellSpan reported that as due to the high demand for the COVID



-19 vaccine, all available appointments have been filled. They ask for our community's patience as they work to make more appointments available. Appointments will depend on vaccine availability. Pennsylvania is currently getting 143,000 doses per week, with regional health providers not getting all their requested supply. The federal government is proposing 15-17% increase in dosage next week. Hopefully that comes to fruition but is still speculative. It is being reported that Johnson & Johnson will be ready to roll-out an additional vaccine next week.

WellSpan has indicated that while waiting for updates on new appointments, to use or create a "MyWellSpan" account to make the appointment and scheduling process easier. You do not have to be a WellSpan patient to create an account. Rotating Regional Pop-up COVID Testing Sites

The PA DOH has begun a program of pop-up COVID-19 testing sites around the Commonwealth. Last week Adams County Department of Emergency Services was one of the locations. Approximately 400 tests were given. Yesterday through this coming Tuesday, Adams County residents can access a site in Cumberland County at the Army War College, Army Heritage Education Center, 950 Soldiers Dr., Carlisle, PA, 17013

No appointment is necessary for these tests. Register at the site. Bring a photo-ID and insurance card. Patients are not required to show symptoms of COVID-19 in order to be tested and anyone can get tested

Court Hearing Update

With more court hearings moving to the Human Services Building (HSB) and attempting to adapt these hearings to the COVID dynamics, I thought it might be useful to spend a moment clarifying the Court schedule.

Central Court convenes on Wednesdays at HSB mostly for Preliminary Hearings. The Court is managing two or three courtrooms every Wednesday and doing around 50 cases. That equates to a lot of people and vehicles so HSB has worked well for administration, logistics, parking and security.

Domestic Relations Court, the majority of Juvenile Court, and most criminal court for non-incarcerated defendants is conducted at the HSB is conducted at HSB. Family Court is held at the Courthouse. The Criminal court for incarcerated defendants is via video hearings between the Adams County Correctional Center and the Courthouse. Criminal Business, Criminal and Civil Trials are all held at the Courthouse. Postponed trials will resume March 2021 - assuming COVID-19 does not spike.

There has been a significant increase in home confinement/electronic monitoring due to unavailability of Re-entry (Work Release) Center. It is actually a preferred practice in many cases and the Court anticipates expanded use of electronic monitoring beyond the pandemic.



Some Capital Projects

Adams County has an exciting list of capital projects planned for the next (36) months, totaling just under \$10 Million dollars, taking advantage of historically low interest rates. These projects range from building envelope and energy savings endeavors, to a roof-mount solar project with roof improvements being designed for the Human Services Building, a new fire alarm and fire protection system for the courthouse, and a life-time license to launch an electronic filing system in the Prothonotary's office.

New Regional Transit Authority Being Formed

A new regional transit authority is in the process of formation and includes Adams and York counties. The new authority will include Rabbit Transit. It is hoped that this new authority will increase ridership in Adams County, and provide Adams County employers with a broader base from which to attract potential employees; while allowing Adams County residents more transportation opportunities. It should especially enhance service between Gettysburg, New Oxford and Hanover.
