5 **ORDER OF COURT**

6 AND NOW, this 27th day of July, 2022, IT IS HEREBY ORDERED that in addition to fees
7 and charges imposed by a statute or by the Supreme Court of Pennsylvania, the following fees shall be
8 assessed as costs in every misdemeanor or felony criminal case in which the defendant has been placed
9 in the accelerated rehabilitative disposition program, probation without verdict, or convicted unless
10 otherwise provided by Administrative Order of Court:

11 1. All cases:

- 12 a. a community service fee in the amount of \$35 paid to the Adams County General Fund and
13 designated as budget revenue for the Adams County Department of Probation Services;
- 14 b. a drug and alcohol test fee in the amount of \$20 paid to the Adams County General Fund
15 and designated as budget revenue for the Adams County Department of Probation Services;
- 16 c. a law enforcement fee in the amount of \$20 to be forwarded to the Adams County
17 Treasurer's Office for deposit in the law enforcement fund account (Administrative Order
18 No. 15 of 2009);
- 19 d. a booking center fee in the amount of \$300 for deposit in the Central Booking Fund
20 (Administrative Order No. 15 of 2009); and
- 21 e. a local offender supervision fee in the amount of \$40 per month (Administrative Order No.
22 8 of 2022).

23 2. Costs for driving under the influence of alcohol/controlled substance under 75 Pa. C.S.A. §
24 3802:

- 25 a. all fees imposed in paragraph 1 above;

- b. an education fee in the amount of \$145 payable to the Adams County General Fund as budget revenue for the Adams County Department of Probation Services (Administrative Order No. 31 of 2013);
- c. a CRN fee in the amount of \$35 payable to the Adams County General Fund as budget revenue for the Adams County Department of Probation Services (Administrative Order No. 31 of 2013);
- d. a victim impact panel fee in the amount of \$10 (Administrative Order No. 27 of 2013); and
- e. an offender treatment fee in the amount of \$20 payable to the Court Offender Treatment Fund identified in the Adams County Treasurer's Office as account C2-02 (Administrative Order No. 31 of 2013).

- 3. In all A.R.D. cases (in addition to fees imposed above):
 - a. an administrative fee in the amount of \$300.
- 4. In all cases where a DNA sample is required by law to be provided and the sample is taken at the Adams County Correctional Facility, the Adams County Department of Probation Services, or a place designated by the Court, a DNA sample fee of \$25 shall be assessed. Notice of drawing of the sample shall be provided by either the Correctional Facility or the Department of Probation Services to the Adams County Clerk of Courts Office and the same shall be assessed as costs. Fees paid pursuant to this Order shall be paid to the Adams County General Fund and designated as budget revenue for the Adams County Department of Probation Services.

This Order shall become effective on September 9, 2022, at which time Administrative Order No. 35 of 2013 shall be vacated.
