## Adams County Drug Dealers Arrested

Adams County District Attorney Brian Sinnett announced today that members of the Pennsylvania State Police, the Adams County Drug Task Force, and the Gettysburg Borough Police Department along with several other law enforcement agencies charged thirteen individuals who are alleged to be selling drugs in the Adams County area, as a result of a months-long drug investigation. These individuals as well as the crimes charged against them are provided on the attached page.

The primary focus of this drug investigation was the sale of cocaine in Gettysburg Borough and its surrounding area, following numerous anonymous tips and complaints about the sale of cocaine in Gettysburg Borough. As a result of these arrests, several alleged local drug dealers have been arrested and placed in the Adams County Adult Correctional Complex to await trial on their charges, and a number of arrest warrants have been issued for other alleged drug dealers. Further, as a result of these arrests, police also seized a significant amount of U.S. Currency, as well as other drugs and drug paraphernalia.

Sinnett thanked the Pennsylvania State Police, the Adams County Drug Task Force, the Gettysburg Borough Police Department, and the Littlestown Borough Police Department for their continued excellent efforts in this endeavor. Also, Sinnett specifically thanked members of the community in Gettysburg Borough as well, as many of the alleged drug dealers in Gettysburg Borough were brought to the attention of the Pennsylvania State Police and the Adams County Drug Task Force as a result of citizen tips communicated through the Gettysburg Borough Police Department. This is evidence of what we can do as a collaborative effort between members of the community and law enforcement. Tipsters may remain anonymous. The prosecution of all of these matters will be handled by Assistant District Attorney Robert A. Bain II.

In this case, as with all criminal cases, the accused are presumed innocent until proven guilty.
