

Adams County Commissioners Update – April 3, 2020

- Following the Governor’s Statewide *Stay At Home Order* on Wednesday, which is in effect through April 30, Adams County Government will continue its closure to the public through May 3, pending any change in state administrative guidelines. County buildings are closed to the public, except for essential services and emergency Court hearings or filings. Staff is currently on a work from home status, with all Departments operational with phone and email communication.

With an eye toward providing both effective Human and Fiscal service to our residents, and quality of life concerns for county staff, given the extension of the quarantine, the Board of Commissioners will be examining various available options for operating in a fiscally prudent manner, while recognizing and balancing staff and community needs.

- Today is the first day to apply for the *Paycheck Protection Program*. Small business and non-profits can apply through their lending institution for reimbursement for retaining their employees during this pandemic. Obtain information from your lending institution. Today at 5PM is the cut-off to apply to the Governor’s Office for waivers to keep businesses open. Go to expressforms.pa.gov for a DCED Waiver Process for a Keeping Physical Locations Open form.
- As of today, Pennsylvania is reporting 8420 confirmed cases with 102 deaths. That is 12 more deaths since yesterday. Note that fortunately, on the county case counts listed below, Adams County’s numbers are lower than all the county’s that surround us. According to experts we have not yet hit the apex of the curve, so let’s follow all recommended precautions and practices to reduce and suppress this number.
