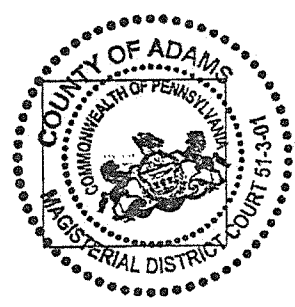

## AFFIDAVIT of PROBABLE CAUSE

On 12/15/2013, at approximately 1120 hours, victim S.E.K. reported a sexual assault to the Gettysburg Police Department. S.E.K. told officers that she and some friends went to a party at the Gettysburg College to celebrate the end of finals. S.E.K. stated that while at the party there was a "kid" there that was creeping her out. The kid that S.E.K. was referring to was later identified as Ian Thomas CLEARY. S.E.K. decided to leave the party with a friend who walked with her to her dorm. While walking, S.E.K. and her friend noticed that CLEARY was following them. S.E.K. stated that while they were walking up the stairs towards her dorm room, CLEARY offered her friend twenty (20) dollars for him to leave her with him. S.E.K.'S friend told CLEARY to go away, and he did.

S.E.K. advised that her friend dropped her off at her dorm room at approximately 0245 hours. Approximately ten (10) minutes later, she heard a knock on her door. Expecting the person knocking to be another friend, S.E.K. proceeded to open the door without looking through the peephole, and when she opened the door CLEARY walked into her room.

While CLEARY was in the room he began kissing S.E.K. They laid down on her bed and then he removed her pants and proceeded to have intercourse with her. S.E.K. advised that she did not consent to anything. S.E.K. said to CLEARY "what are you doing?" and he kept going. S.E.K. told him to stop. Afterwards, CLEARY said to S.E.K. "I'm sorry. Are you okay?" and then left her room.

At approximately 0250 hours, S.E.K. sent text messages to her friend stating "Help please" and "OMG please Help me".

S.E.K. estimated that the sexual assault occurred at around 0300 hours.

On 5/31/2020, S.E.K. contacted the Adams County District Attorney's Office in reference to messages she received from Ian CLEARY via Facebook Messenger. The messages are as follows:

- December 8th, 2019 @ 1339 hours. "I need to hear your voice. I need to know if I did it or not". "I wanted to but I couldn't. Don't worry".
- December 8th, 2019 @ 1414 hours. "I'll wait for you." "I'll pray for you." "I kissed you. I grabbed your breasts. Then I tried to but I couldn't because I was high. Then I had to catch a plane. That's why I ran. It was like 5am plane."
- December 9th, 2019 @ 0245 hours. "I played with you but I didn't penetrate you".
- December 9th, 2019 @ 0351 hours. "So I raped you".
- December 9th, 2019 @ 0443 hours. "I'll never do it to anyone ever again". "I'm going stay". This was the last message sent by CLEARY.

A search and seizure warrant for Ian CLEARY'S Facebook account was obtained. The search warrant results for Ian CLEARY'S Facebook account revealed that the account was verified by cellular telephone number 408-761-2455 on 12/19/2015. A check through the Gettysburg College Department of Public Safety verified that former student Ian Thomas CLEARY had the same cellular telephone number of 408-761-
