PSATS Reminder

You should have just received PSATS Resolutions adopted and message if you haven't taken time to read it, check out Guidance on Act 172 of 2016. It allows local governments to grant fire and emergency medical service volunteers tax credits for local taxes. This is an optional tax and municipalities have to pass an ordinance to enact it. PSATS has offered a sample ordinance to adopt.
