ORDINANCE NO. 1-66

AN ORDINANCE CREATING A PLANNING COMMISSION
AND CREATING A ZONING COMMISSION WITH THE
SAME PERSONNEL ACTING IN BOTH CAPACITIES,
PROVIDING FOR THE APPOINTMENT OF PERSONNEL
THERE TO AND THE DUTIES THEREOF.

BE IT ENACTED AND ORDAINED by the Township of Hamiltonban,
Adams County, Pennsylvania, and it is hereby enacted and ordained by
authority of the same and by authority of the Pennsylvania Act of Assembly
entitled, "Second Class Township Code" as follows:

Section 1. A commission to be known as the Planning Commission
to be in charge of township planning, consisting of five persons to be
appointed by the Hamiltonban Township Supervisors, is hereby created.

Section 2. A Zoning Commission with the same personnel as the
Hamiltonban Township Planning Commission, to be in charge of Hamiltonban
Township zoning, consisting of the same five persons as appointed to the
Hamiltonban Township Planning Commission, is hereby created.

Section 3. In the first appointment by the Hamiltonban Township
Supervisors of members to said commissions, one member shall be appointed
for one year, one member for two years, one member for three years, one
member for four years and one member for five years, and annually thereafter,
a member of said Commissions shall be appointed for a term of five years.

Section 4. The filling of vacancies and the residence requirements and the compensation provided shall be determined by the provisions of the Act of the Pennsylvania Assembly, known as the "Second Class Township Code".

Section 5. Said Commissions shall exercise the powers and perform the duties as may from time to time be set forth and authorized in the Act of Pennsylvania Assembly known as the "Second Class Township Code", as pertaining to planning and zoning.

Section 6. Finances and expenditures by said Commissions shall be submitted to the Supervisors of Hamiltonban Township for approval and appropriated by the Supervisors of Hamiltonban Township before expended.

Section 7. The following persons, together with their addresses and terms of office, all of whom are residents of Hamiltonban Township, Adams County, Pennsylvania, shall act as the first appointees of the Hamiltonban Township Supervisors to the Hamiltonban Township Planning Commission and Hamiltonban Township Zoning Commission as follows:
