

RESOLUTION 2019-04

A RESOLUTION AMENDING FEE SCHEDULE FOR CERTAIN MUNICIPAL SERVICES OF LIBERTY TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA

Be it resolved by the Board of Supervisors of Liberty Township, Adams County, Pennsylvania amending Resolution 2019-02. Be it hereafter that the following fee schedule is hereby adopted to apply to all matters pertaining to certain municipal services in accordance with Liberty Township Ordinances and intended to be adopted effective October 1, 2019 as outlined below.

- Land Use Permit (Residential & Commercial)
o Application Fee and up to 1 hour of Zoning Officer Consultation..... \$90
o Cost per hour for each additional hour of Zoning Officer Consultation... \$45
• Land Use Permit - In Home/Nonimpact Business..... \$50
• Land Use Permit Extension.....50% of original permit fee
• Demolition Permit..... \$55
• Driveway Permit..... \$65
• Zoning Hearing Board or Conditional Use Application..... \$800
• Special Events Permit..... \$500
• Junkyard License Fee Per Calendar Year..... \$100
• Subdivision and Land Development Application
o Administrative Fee..... \$50
o Escrow Deposit for Township Professional Review Fees - See attached Sheet for Professional Fees..... \$1,250
• Stormwater Management Plan Application
o Administrative Fee..... \$50
o Escrow Deposit for Township Professional Review Fees - See attached Sheet for Professional Fees..... \$750
• Septic Pumping Inspection Report Filing Fee..... \$10
• Returned Check Fee..... \$45
• Document Copy Fee (Per page per side of 8 1/8 x 11 sheet) \$0.25




