

**RESOLUTION OF THE BOROUGH COUNCIL OF THE  
BOROUGH OF LITTLESTOWN, ADAMS COUNTY  
PENNSYLVANIA, ESTABLISHING A POLICY TO SET FORTH STANDARDS OF  
PAYMENT PLANS AND ACCEPTABLE FORMS OF PAYMENT FOR  
LATE WATER AND SEWER ACCOUNTS**

**WHEREAS**, it is deemed by this Council that the following policy is being established to set forth standards of payment plans and acceptable forms of payment after a water/sewer bill is deemed late:

**PAYMENT PLANS:**

1. Payment plans are offered every quarter to homeowners and tenants
2. If the property is a rental unit, a landlord permission form must be submitted by the property owner to allow tenant permission to set up a payment plan
3. Payment plans will only be established by returning the signed bottom portion on your quarterly bill along with the first payment listed under "for payment plan option please pay amounts below".
4. If one is unable to come in then the payment plan can be picked up by someone other than the person signing up for the payment plan. Payments received in an amount lower than the first and second payments listed on the bill and without the signed bottom portion of the bill will result in no payment plan being established.
5. Payments being submitted must be no less than the amounts stated under the payment plan option on the quarterly bill.
6. Payment plans extend the billing due date and amount into two equal monthly payments
7. The first payment must be made on or before the billing due date
8. The second payment must be made on or before the last business day of the month following the first payment due date
9. If the plan is defaulted on by making a late or no payment, the plan is automatically voided. No late payments will be accepted.
10. Defaulted payment plans, on any outstanding balance, will be assessed a 10% penalty immediately and after 30 days will be assessed 1.5% interest. Interest charges are accrued on a monthly basis on the gross adjusted amount.
11. The only acceptable forms of payments for defaulted payment plans are: cash, credit card, money order or certified checks. No personal checks, company checks, online bank checks or e-checks will be accepted. No exceptions.
12. No payment plans will be made after the third (3<sup>rd</sup>) defaulted plan. All future bills will need to be paid for by the billing due date.

**ACCEPTABLE FORMS OF PAYMENT FOR LATE WATER/SEWER BILLS**


1. Water and Sewer bills go out quarterly, January, April, July and October. Each bill is due by the last business day of the billing month
2. If not paid by due date a 10% penalty will be assessed immediately and after 30 days 1.5% interest will be assessed. Interest charges are accrued on a monthly basis on the gross adjusted amount.
3. The only acceptable forms of payments for late accounts are: cash, credit card, money order or certified checks. No personal checks, company checks, online bank checks or e-checks will be accepted. No exceptions.

**NOW, THEREFORE, BE IT RESOLVED**, and it is hereby RESOLVED by the Borough of Littlestown, by the Littlestown Borough Council, hereby establishes the above policies. This policy supersedes any previous policies that have been set.
