



Dear Parents/guardians,

Your child is being invited to spend a summer of fun and games with his or her friends. The Summer Recreation Program will run **Monday thru Thursday** beginning **JUNE 18th** and ending **JULY 26th** from **8:00 am to 11:30 am**. Please arrange for your child to be picked up no later than **11:30 am** and **DO NOT** drop your child off earlier than **8:00 am**. There will be NO supervision for your child after 11:45 am each day. Due to limited staffing, only students who live in the LittlestownAreaSchool District and are in grades K-6 will be permitted to attend the program. Each child must have completed Kindergarten to attend and **may not be going into grade 7** or above. **THIS IS NOT A BABYSITTING SERVICE!!** DO NOT bring children that are not interesting in playing recreational games or doing crafts. You will be asked to remove your child if he/she is not interesting in playing athletic games.

The Summer Recreation Program will be taking place in the Cafeteria, at the Alloway Creek Intermediate School. Your child(ren) must be picked up and dropped off at the cafeteria side of Alloway Creek. Juice and water will be offered each day for **fifty cents** each. Your child must pay daily if he or she wants juice or water. We will not accept weekly payments.

There are several events planned for the summer and you will be updated with periodic newsletters. Also, in order for everyone to have fun and remain safe, it is important for your child to cooperate with all staff members and follow the rules. Any persistent discipline problems will result in dismissal from the program.

Please complete the attached registration and transportation forms and have your child bring them the first day of the program. There are also two *Rules and Consequences* forms. Please have you and your child sign and keep a form explaining the rules and consequences for wrong behavior. Keep one copy for yourself.

Summer Rec Rules and Consequences
