

Such costs may include notice and advertising costs and necessary administrative overhead connected with the hearing, and shall include half of the appearance fee for the stenographer as authorized by the Pennsylvania Municipalities Planning Code (Act 247 of 1968, as re-enacted and amended). Such costs shall not include the legal expenses of the Zoning Hearing Board, legal expenses of the Board of Supervisors, or expenses for engineering, architectural or other technical consultants or expert witness costs.


