

**OXFORD TOWNSHIP**

**ORDINANCE NO. 2019-120**

**AN ORDINANCE OF THE TOWNSHIP OF OXFORD, ADAMS COUNTY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 15 OF THE CODE OF ORDINANCES OF THE TOWNSHIP OF OXFORD, WITH RESPECT TO: SECTION I RELATING TO MAXIMUM SPEED LIMITS ON CERTAIN STREETS, SECTION II RELATING TO STOP SIGNS, SECTION III RELATING TO TRUCK TRAFFIC, SECTION IV RELATING TO PARKING REGULATIONS, AND ARTICLE V RELATING TO SNOW EMERGENCY ROUTES**

**BE IT ENACTED and ORDAINED**, and it is hereby enacted and ordained by the Board of Supervisors of the Township of Oxford as follows:

SECTION 1: Section 201(1) of Chapter 15 of the Code of Ordinances of the Township of Oxford is hereby amended to establish speed limits upon additional streets within the Township as follows:

<u>Street</u>	<u>Between</u>	<u>Maximum Speed Limit</u>
Katelyn Drive	Entire length	25 mph

SECTION 2: Section 213(1) of Chapter 15 of the Code of Ordinances of the Township of Oxford is hereby amended to establish additional stop intersections within the Township as follows:

<u>Stop Street</u>	<u>Intersecting or Through Street</u>	<u>Direction of Travel</u>
Katelyn Drive	Brickyard Road	North
Katelyn Drive	Katelyn Drive	East

SECTION 3: Section 304(1) of Chapter 15 of the Code of Ordinances of the Township of Oxford is hereby amended to restrict truck traffic within the Township as follows:

<u>Street</u>	<u>Between</u>
Katelyn Drive	Entire Length

SECTION 4: Section 405 of Chapter 15 of the Code of Ordinances of the Township of Oxford is hereby amended to prohibit the parking of certain vehicles on additional streets as follows:

<u>Street</u>	<u>Between</u>
Katelyn Drive	Entire length

SECTION 5: Section 603 of Chapter 15 of the Code of Ordinances of the Township of Oxford is hereby amended to establish additional snow emergency routes as follows:

<u>Street</u>	<u>Between</u>
Katelyn Drive	Entire length


SECTION 6: The provisions of this Ordinance shall be effective immediately.
