GENERAL SUMMARY NOTES OF ORDINANCE #2014-01 §13-201 TO §13-213:

- Applications must be accompanied by a license fee of thirty-five dollars (\$35.00).
- EACH solicitor or peddler must make a separate application, pay an application fee, and issued a separate license.
- Licenses are NOT transferable from one person to another.
- The Township shall investigate the facts set forth in the application within five (5) business days.
- Day and Hours of solicitation/peddling: ONLY Monday through Friday during the hours of 10:00AM to 6:00PM, prevailing time.
- Solicitation or Peddling Licenses are valid for 30 days from date of issue unless revoked for just cause.
- Licenses can be renewed prior to expiration of the 30 days by applying for renewal and paying a renewal fee of five dollars (\$5.00).
- If issued a license to Solicit or Peddle in Reading Township, the licensee must keep the license upon his/her person while soliciting or peddling in the Township.
- No licensed solicitor or peddler shall hawk or cry his/her wares/services, nor use any loudspeaker, bell, whistle or other noise making devise unless express permission is grated.
